The North Collin Special Utility District ("NCSUD" or "District") Board of Directors will hold a Special Board of Directors' meeting on Thursday, July 25, 2024 at 7:00 p.m. at NCSUD office at 2333 Sam Rayburn Hwy., Melissa, TX 75454. This meeting will be held in accordance with the following:

### Agenda

1. Call to order and Roll Call.
2. Hear public comments. (The NCSUD Board will hear public comments for items not listed on the agenda, but any discussion shall be limited to the item being placed on a future agenda for further consideration or, if appropriate, direct the speaker to District staff for more information. Limit individual comments to three minutes with a maximum of fifteen minutes total for public comments.
3. Discuss and take appropriate action regarding additional meter at 3630 CR 413.
4. Discuss and take appropriate action regarding the City of Melissa providing water service to Vineyard Hill Estates.
5. Discuss and take appropriate action regarding becoming a Wastewater Provider customer of NTMWD and other actions in connection therewith.
6. Discuss and take appropriate action regarding NTMWD water supply delivery point.
