## **Board of Directors' Meeting**


The North Collin Special Utility District ("NCSUD" or "District") Board of Directors will hold a Regular Board of Directors' meeting on Thursday, March 21, 2024 at 7:00 p.m. at NCSUD office at 2333 Sam Rayburn Hwy., Melissa, TX 75454. This meeting will be held in accordance with the following:

### Agenda

1. Call to order and Roll Call.
2. Hear public comments. (The NCSUD Board will hear public comments for items not listed on the agenda, but any discussion shall be limited to the item being placed on a future agenda for further consideration or, if appropriate, direct the speaker to District staff for more information. Limit individual comments to three minutes with a maximum of fifteen minutes total for public comments.)
3. Recess into Executive Session according to Tex. Gov't Code Section 551.071-Private consultation with the District's attorney, Section 551.072 Discussing purchase, exchange, lease, or value of real property, and Section 551.074 Personnel Matters in regards to the following:
  - a. North Collin Special Utility District v. Public Utility Commission of Texas, et. al; Cause No. D-1-GN23-002095 in the 98<sup>th</sup> District Court of Texas (Travis County) to appeal Public Utility Commission of Texas, Docket No. 52442; Petition of Meritage Homes of Texas, LLC to amend North Collin Special Utility District's Certificate of Convenience and Necessity in Collin County by Expedited Release.
  - b. North Collin Special Utility District v. Commissioners of the Public Utility Commission of Texas (PUC); Executive Director of the PUC; Meritage Homes of Texas, LLC, in the United States District Court for the Western District of Texas (Austin Division); Case 1-21-cv-807-RP; including issues regarding Meritage/GRBK Edgewood removal of the District's 2" waterline on the related Meritage property.
  - c. North Collin Special Utility District v. City of Princeton, Texas, in the United States District Court for the Eastern District of Texas (Sherman Division); Case 4:23-cv-00002-ALM.
  - d. Other pending or contemplated litigation, and settlement offers.
4. Reconvene into Regular Session and take appropriate action relating to the items of discussion in Executive Session.
5. Discuss and take appropriate action to approve minutes of previous meeting/s.
6. Discuss and take appropriate action to accept monthly financial report.
7. Discuss and take appropriate action regarding the New Hope area overhead storage tank.
8. Discuss and take appropriate action regarding new transfer pumps at #1 Pump Station.
9. Discuss and take appropriate action regarding Resolution No. 2024-002, authorizing the District's General Manager to execute a purchase and sale agreement for the acquisition of certain real property located at 6084 N. McDonald Street in Melissa, Texas; providing for other matters in connection therewith; and providing an effective date.
10. Discuss and take appropriate action regarding Ordinance No. 2024-003, ratifying, reaffirming, and re-approving the District's monthly rates and gallonage charges; amending and restating Section G.6 of the District's Rate Order accordingly; providing for severability, conflicts and savings, and an effective date.
11. Discuss and take action regarding request for NCSUD to provide water service to 8071 CR 470, Blue Ridge, Texas, located in Verona Special Utility District's service area.
12. Manager's Report, including but not limited to:
  - a. System maintenance and repairs
