The North Collin Special Utility District ("NCSUD" or "District") Board of Directors will hold a Board of Directors' meeting on Thursday, November 20, 2025 at 3:00 p.m. The meeting will be held at NCSUD office at 2333 Sam Rayburn Hwy., Melissa, TX 75454. This meeting will be held in accordance with the following:

- Hear public comments. (The NCSUD Board will hear public comments for items not listed on the agenda, but any
  discussion shall be limited to the item being placed on a future agenda for further consideration or, if appropriate,
