Agenda

1. Call to order and Roll Call.
2. Hear public comments. (The NCSUD Board will hear public comments for items not listed on the agenda, but any discussion shall be limited to the item being placed on a future agenda for further consideration or, if appropriate, direct the speaker to District staff for more information. Limit individual comments to three minutes with a maximum of fifteen minutes total for public comments.
3. Recess into Executive Session according to Tex. Gov't Code Section 551.071-Private consultation with the District's attorney, and Section 551.072 Discussing purchase, exchange, lease, or value of real property, in regards to the following:
 - a. North Collin Special Utility District v. Sheryl Lynn Bates, Eminent Domain Proceedings in the Collin County Court at Law No. 4, Cause No. 004-02260-2025.
 - b. Other pending or contemplated litigation, and settlement offers.
 - c. Purchase of real property.
4. Reconvene into Regular Session and take appropriate action relating to the items of discussion in Executive Session.
5. Discuss and take appropriate action regarding a Potable Water Supply Contract by and between North Texas Municipal Water District and North Collin Special Utility District, superseding and replacing previous water supply contracts between the parties.
